## part time Gender and Youth Policies expert

The position reports to the MIO-ECSDE Head Officer and the You(th) Care Project Officer.

## **Background and Scope of Position**

The part-time Gender and Youth Policies expert will be engaged in the <u>You(th) Care for Change</u> Programme (2024-2027) activities on gender equality and youth empowerment in which MIO-ECSDE is the national partner for Greece.

#### **Job Profile**

Primary responsibility will be to follow the <u>You(th) Care for Change</u> Programme activities that focus on gender equality and women's rights.

Local and international travels may be required.

The main duties and responsibilities are:

- 1. Technical coaching and assessment of pilot You(th)Care actions in Greece in cooperation with the Project Officer and the Country focal Officer; these will be small scale youth-led activities by Greek youth groups that will be submitted for approval under the Call to be initiated by the You(th) Care Project (3-5 actions to be approved).
- 2. Organization of online and/or onsite (in Greece) capacity buildings in cooperation with the Project Officer on gender equality and economic and ecological transition, women's rights, gender empowerment and mainstreaming.
- 3. Participation in the meetings of WP3 and WP4 on gender of the You(th) Care for Change Programme.
- **4.** Contributing expert advice on the gender equality and youth inclusion aspects of existing and new activities, programmes and advocacy actions of MIO-ECSDE, as needed.

### 5. Values and Ethics

The candidate should have a high level of integrity, accountability, and punctuality. He/she should also demonstrate and be exemplary in portraying MIO-ECSDE values and ethics. He/she should be a good team player. Communications must remain neutral with regard to the geo-political/political and security related sensitivities of the MIO-ECSDE projects' beneficiary countries.

#### 6. Qualification and other Requirements

*Education:* First Academic Degree on Environmental Sciences, Master's Degree related to environmental issues, management and diplomacy.

**Experience:** At least five years of working experience on gender and youth related topics in environmental and sustainability focused projects. Candidate should be able to work independently —with minimum supervision and guidance from supervisors. A good understanding of the socio-economic and political background in Greece, Europe and the Mediterranean is an asset as is also working experience in an international academic institution or NGO. The candidate should have experience of at least one policy related paper drafted and a study on gender mainstreaming.

Skills: Excellent written and oral Greek, English and French communication skills are required. Excellent eskills, including the ability to use modern office technology and related software. Practical knowledge of word processing, spreadsheet, and presentation software is required. He/she should have advanced working knowledge of MS Office (Word, Powerpoint, Excel). Ability to organize and animate capacity building activities is essential. Fluency in any other language of the countries which You(th) Care for Change Programme supports (Italy, Spain, France, Belgium, Luxembourg, Czech Republic, Hungary, Greece, Albania, Serbia, Tunisia, and Morocco) will be considered as an asset.

- Coordinate well with diverse individuals and teams, and particularly youth, and work effectively with colleagues and stakeholders to achieve results.
- Apply principles of ethics, transparency and non-discrimination.
- Display gender, cultural, religion, race, nationality and age sensitivity and adaptability.
- Treat all people fairly without favoritism.
- Fulfill all obligations to gender sensitivity and zero tolerance for sexual harassment.
- Be open to change and ability to receive/integrate feedback.
